INTRODUCTION

ICC, through a dedicated group of experts from the ICC Informal Project group on AI, has developed a unifying narrative, outlining the four overarching pillars of global AI governance from the perspective of global business: principles and codes of conduct, regulation, technical standards, and industry self-regulation, illustrated by business best practices (case studies). The narrative shows, how by adhering to these frameworks, businesses drive innovation, ensure compliance, and build trust, contributing to sustainable and inclusive growth. The narrative is expected to be released in the autumn of 2024.

To help bolster the messages of this narrative, ICC member companies of all sizes and sectors are invited to submit case studies **by 16 August COB** to show how their company is taking initiative to:

- implement principles and guidelines for trustworthy, responsible and ethical AI; and
- respond to specific AI-related policy challenges.

Case studies can be submitted under two categories:

1. Internal or external company policies implemented in response to existing principles and guidelines

- Ethics, human rights and fairness: *commitment to respect the rule of law, human rights, democratic and human-centred values throughout the AI system lifecycle, including non-discrimination, equality, diversity, freedom, dignity, autonomy of individuals, and protection of fundamental rights and freedoms*
- Safety: *commitment to set guardrails against misuse and mitigate risks related to harmful bias*
- Security: *commitments to cybersecurity, data protection, privacy*
- Accountability: *commitments to ensure traceability, including in relation to datasets, processes and decisions made during the lifecycle of an AI system, to enable the analysis of its outputs and responses to inquiries, as well as to apply a systematic risk management approach*
- Transparency and explainability: *commitments to provide, wherever possible, meaningful information that enables a general understanding of an AI system, its capabilities and limitations, its output and way of reaching that output as well as information that enable those adversely affected by an AI system to challenge its output*
- Inclusive growth: *commitment to beneficial outcomes for people, planet, and prosperity such as advancing inclusion of underrepresented populations, reducing economic, social, gender and other inequalities, and protecting natural environments*
- Partnership: *commitment to work together with industry partners to share information and best practices*

2. Focused projects responding to potential challenges related to AI

- Mis- and disinformation
