## First Climate Week 2025: UNFCCC Technical Meetings

# 1. Global Dialogue and Investment-focused Event on Mitigation Ambition and Implementation

ICC has the opportunity to nominate **four (4) business representatives for in-person participation and four (4) representatives for virtual participation** in the 5<sup>th</sup> global dialogue and investment-focused event under the Sharm el-Sheikh mitigation ambition and implementation work programme, which will take place in a hybrid format in **Panama City**, **Panama, from 19 to 20 May 2025**.

At COP26, Parties agreed to establish a work programme to scale up mitigation ambition and implementation. COP27, Parties set further details, including at least two global dialogues and investment-focused events annually through 2026. The upcoming dialogue will address enabling mitigation solutions in the forest sector.

## 2. Third Dialogue under the United Arab Emirates just transition work programme

ICC has the opportunity to nominate **four (4) business representatives for in-person participation and four (4) representatives for virtual participation** in the 3<sup>rd</sup> global dialogue under the United Arab Emirates work programme on just transition pathways, which will take place in a hybrid format in **Panama City, Panama, from 22 to 23 May 2025**.

At COP28, Parties agreed on the implementation of the five-year work programme on just transition pathways (JTWP), established at COP27, with the mandate to hold at least two hybrid dialogues per year. The upcoming 3<sup>rd</sup> dialogue will focus on **"Approaches to enhancing adaptation and climate resilience in the context of just transitions".** Details on the previous dialogues held in 2024 are available <u>here</u>.

The Forum will serve as the official launch of the "Article 6.4 DNA Forum" and provide opportunities for Party representatives to exchange views and share their experience related to the implementation of Article 6.4 mechanism and experiences from the CDM.
