2nd Global Dialogue on the Impacts of the Implementation of Response Measures and the 13th meeting of the Katowice Committee of Experts (KCI)

ICC has the opportunity to nominate **two (2)** in-person and up to **four (4)** virtual representatives from the Business and Industry Constituency to participate in the **Second Global Dialogue on the Impacts of the Implementation of Response Measures**, taking place **from 29 to 30 September 2025**, in **Istanbul, Türkiye**, and the **13th meeting of the Katowice Committee of Experts (KCI)**, scheduled for **1 to 3 October 2025** in the same city.

Regarding the 2nd Global Dialogue, at COP28 in Dubai, Parties decided to convene a two-day global dialogue on the impacts of the implementation of response measures, to be held in conjunction with intersessional meetings of the KCI in 2024 and 2025, in collaboration with relevant organisations and stakeholders. The SB Chairs will decide on and communicate the topics of the dialogue by 1 September 2025.

Workshop under the UAE–Belém work programme on indicators

ICC has the opportunity to nominate **two (2) representatives** from the Business and Industry Constituency to participate in-person and additional representatives to participate virtually in the technical **Workshop under the UAE–Belém work programme on indicators**, which will take place from **20 to 21 October 2025** in **Bonn, Germany**.

At COP28, in the context of a decision on the Global Goal on Adaptation (GGA), Parties launched a two-year UAE-Belém work programme carried out by the SB Chairs on indicators for measuring progress achieved towards adaptation targets, with a view to identifying and developing indicators and potential quantified elements for those targets. At SB60 in June 2024, countries requested the SB Chairs to convene [technical experts](#) to assist in the technical work and to organise two hybrid workshops for Parties, experts and observers under the work programme. The [first workshop](#) took place in June earlier this year to take stock of the progress of work by the technical experts, and the second one will reflect on the final list of potential indicators to be agreed at COP30.
